(1) PROPOSED APPOINTMENT OF EXECUTIVE DIRECTOR; AND (2) 2024 FIRST EXTRAORDINARY GENERAL MEETING

1. INTRODUCTION

On behalf of the Board, I invite you to attend the EGM to be held at 2:30 p.m. on Thursday, 4 January 2024 at the meeting room of the Company on the 1st floor at Wastewater Treatment Plant No. 7, Kunming Dianchi Tourist Resort, Yunnan Province, the PRC.

The purpose of this circular is to provide you with the information reasonably necessary to enable you to make an informed decision on whether to vote for or against the proposed resolution at the EGM.

2. BUSINESS TO BE CONSIDERED AT THE EGM

The business to be considered at the EGM is described in more detail in the notice of the EGM as set out on pages 7 to 8 of this circular.

Resolution to be proposed at the EGM and proposed to be passed as an ordinary resolution include:

(a) to consider and approve the appointment of Mr. Miao Xianjun as an executive Director.

In order to enable you to have a better understanding of the ordinary resolution to be proposed at the EGM and to make an informed decision in the circumstance where sufficient and necessary information is available, we have provided detailed information in this circular.

3. TO CONSIDER AND APPROVE THE APPOINTMENT OF MR. MIAO XIANJUN AS AN EXECUTIVE DIRECTOR

Reference is made to the announcement of the Company dated 30 November 2023 in relation to the proposed appointment of Mr. Miao Xianjun (\pm \pm) ("**Mr. Miao**") as an executive Director.

As considered and approved by the Company at the 195th meeting of the first session of the Board held on 30 November 2023, Mr. Miao was proposed to be appointed as an executive Director of the first session of the Board, and a resolution in relation to the proposed appointment of Mr. Miao as an executive Director will be submitted at the EGM for consideration and approval by the Shareholders. The aforementioned proposed appointment will be subject to approval by the Shareholders at the EGM by way of ordinary resolution.

Biographical details of Mr. Miao are as follows:

Miao Xianjun, aged 59, graduated from the Central Party School of the Chinese Communist Party majoring in economic management in December 1995.

Mr. Miao studied in an air force unit from November 1980 to June 2002 and successively served as a company commander, a battalion commander and a deputy regimental commander. He served as an assistant researcher and director of department of system reform and regulation in the Kunming Municipal Public Utilities Bureau* (昆明市市政公用局) from June 2002 to July 2006; worked in Kunming Zhongbei Transportation and Tourism (Group) Company Limited* (昆明中北交通旅遊(集團)有限 責任公司) from July 2006 to April 2012 and successively held the positions of deputy secretary of the party committee, deputy general manager, secretary of the party committee and chairman of the board of directors; worked in Kunming Bus Group Co., Ltd.* (昆明公交集團有限責任公司) from April 2012 to November 2021 as secretary of the party committee and chairman of directors, and concurrently served as secretary of the party committee and chairman of directors of Kunming Zhongbei Transportation and Tourism (Group) Company Limited* (昆明中北交通旅遊(集團)有限 責任公司) from April 2012 to March 2019; worked in Kunming Industrial Development and Investment Co., Ltd.* (昆明產業開發投資有限責任公司) from November 2021 to October 2023 as secretary of the party committee and chairman of the board of directors.

The appointment of Mr. Miao as an executive Director will become effective after the resolution of his appointment is approved at the EGM. Thereafter, the Company will enter into a director service agreement with Mr. Miao for a term commencing from the day when the aforementioned resolution is considered and approved at the EGM till the day when the election of the next session of the Board is completed.
